The quoted rates should be inclusive of all taxes including delivery of materials at respective locations of river site, within Guwahati.


DETAILS OF NOTICE INVITING QUOTATION FOR SUPPLY OF MATERIALS

General Scope of Work:


Supply of materials for the office of the Assam Inland Waterways Company Limited as per specifications in ANNEXURE-1, for one year and extended for another one year with both parties understanding.

Terms and Conditions

- 1) NIQ is invited as per procedures as specified in "The Assam Public Procurement Act, 2017" and "The Assam Public Procurement Rules, 2020". These Act and Rules may be viewed and downloaded from the web-link <https://finance.assam.gov.in/portlets/assam-public-procurement-rules-2020>
- 2) The bidders are required to affix in the bid letter a stamp duty of Rs 8.25.
- 3) Minimum 3 (three) Supply Orders within last 3 (three) years relating to supply of materials to IWT/Government Departments/PSUs, etc., must be enclosed with the Quotation to establish that the bidder deals with the supply of maintenance materials/ mooring/ hardware materials.
- 4) Should have annual average turnover of at least Rs.5.00 lakh (Rupees five lakh) only during last three years.
- 5) Should not have been barred by any PSU/Govt. Dept. in doing business with them. (Please submit self-declaration).
- 6) Should submit updated Registration Certificate of IWT, valid trade license, PAN details, GST registration certificate and all relevant up to date tax clearance certificates.
- 7) Should have its base in Assam and must be incorporated & registered under Companies Act/Firm registration act/ Trade License and should be in operations for minimum of last 3 years in the business of relevant field. (submit Proof of Registration).
- 8) An Earnest Money Deposit (EMD) of Rs.6,000/- (Rupees five thousand) only, in the mode of TDR/FDR/DD must be submitted with the quotation. The EMD shall be addressed and pledged to the 'Managing Director, Assam Inland Waterways Company Limited, Ulubari, Guwahati' drawn from any Nationalized Bank. The EMD amount should be valid minimum for one year and further to be renewable, if required.
- 9) The bidder shall have to quote for all the items mentioned in the quotation, otherwise, it shall be disqualified. The quotation must be duly signed on each page by the authorized person of the bidder.
- 10) Each bidder can submit only one quotation.



- 11) Bidder(s) may be present at the time of opening of quotations at the assigned venue, date and time.
- 12) AIWCL will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest quotation, item wise.
- 13) The rate quoted shall be considered as inclusive of all taxes. GST/other taxes shall be deducted while making payments, as applicable, at source.
- 14) The rates quoted shall be inclusive of delivery at site in respective locations as mentioned in the Annex-I, within Guwahati.
- 15) The EMD of unsuccessful Quotationers will be returned after the selection of the successful Quotationers.
- 16) Payment will be made on satisfactory supply of items in full and no request for advance payment will be entertained.
- 17) Rate quoted should be valid for a period of 90 days after the closing date and time of the quotation. Lowest quoted responsive and selected quotationers have to supply the materials at the same quoted price minimum for a period of one year and same rate may be continued for another one year with both parties understanding.
- 18) Any loss or damage to the item(s) while handling/transporting till such time the items are delivered and handed over to this office is the responsibility of the supplier.
- 19) **The Items mentioned in the quotation will be evaluated item-wise.** The bidder shall have to quote price for each item, failing which the quotation shall be rejected.
- 20) If there is any discrepancy between words and figures the amount in words shall prevail prior to detailed evaluation.
- 21) Normal commercial warranty/guarantee of 12 months or more shall be applicable to the supplied items, except the perishable items.
- 22) On completion of successful supplies of ordered quantities, bills/invoices should be raised in triplicate in the name of the Quotation Inviting Authority.
- 23) All terms and conditions and other contents in the quotation shall be final and acceptable to the bidder.
- 24) The selected firm/supplier should be in a position to supply approved items within 24 hours from the time of placing order.
- 25) The approved items should be of standard quality as per specification and of the make specified
- 26) AIWCL reserves the right to accept or reject any quotation/all quotations/ cancel the bidding process without assigning any reason whatsoever. Any dispute, if occurs, shall be under the jurisdiction of the Courts of Guwahati.
